GUIDANCE NOTES

- * Declaration of Group Decisions and Members Interests The Chair of the meeting shall seek declarations from any individual or political group at the beginning of a meeting whether any prior decision has been reached on how the individual or members of the group will vote on any item(s) of business on the Agenda, and if so on which item(s). A prior decision shall be one that the individual or the group deems to be mandatory on the individual or the group members such that the individual or the group members will be subject to sanctions should they not vote in accordance with the prior decision. Any such prior decisions will be recorded in the Minute of the meeting.
- ** Written Questions Any Member can put one written question about any relevant and competent business within the specified remits not already on the agenda, to the Chair provided it is received by the Proper Officer or Committee Services by 12 noon two working days prior to the day of the meeting. A copy of any written answer provided by the Chair will be tabled at the start of the relevant section of the meeting. The Member who has put the question may, after the answer has been given, ask one supplementary question directly related to the subject matter, but no discussion will be allowed.

No supplementary question can be put or answered more than 10 minutes after the Council has started on the relevant item of business, except with the consent of the Chair. If a Member does not have the opportunity to put a supplementary question because no time remains, then he or she can submit it in writing to the Proper Officer who will arrange for a written answer to be provided within 7 working days.

*** Question Time - At each ordinary meeting of the Committee ten minutes will be allowed for Members questions when any Member of the Committee can put a question to the Chair on any business within the remit of that Section of the Committee. The Member who has put the question may, after the answer has been given, ask one supplementary question directly related to the subject matter, but no discussion will be allowed.

No supplementary question can be put or answered more than ten minutes after the Committee has started on the relevant item of business, except with the consent of the Chair. If a Member does not have the opportunity to put a supplementary question because no time remains, then he/she can submit it in writing to the proper officer who will arrange for a written answer to be provided within seven working days.

1. Chair

4. Minute of the Meeting on 11 September 2019

The minute of the meeting of 11 September 2019 was submitted and approved.

5. Written Questions **

The Committee noted that there were no written questions.

6. Sex Entertainment Venues Report

A report by the Depute Chief Executive (Education, Communities and Organisational Development) invited the Committee to consider the responses received to the consultation carried out in relation to the provision of a new licensing regime for sex entertainment venues in Moray, and in light of those responses decide whether sex entertainment venues should be licensed.

Following consideration the Committee agreed to:

- i) note the responses received from the initial consultation process;
- ii) pass a resolution to licence Sex Entertainment Venues in Moray;
- iii) when appropriate instruct the Head of Legal and Democratic Services to publish a draft notice of the resolution as required either electronically or in a newspaper circulating locally; and
- iv) report back to Committee with any responses to a draft resolution along with a full Sex Entertainment Venues application process for approval including forms, guidance and a draft Sex Entertainment Venue policy statement, again developed in consultation with relevant interest groups.

7. Question Time ***

The Committee noted that no further questions were raised.

8. Application for Renewal of a Taxi Driver Licence (Case No. TD/19/005)

A report by the Depute Chief Executive (Education, Communities and Organisational Development) asked Committee to consider an application for renew of a taxi driver licence received on 4 July 2019 subject to an adverse representation received from a consultee.

The Committee noted that the applicant was in attendance. The Chief Superintendent was represented by Sergeant Gillian Flett, Police Scotland.

Sergeant Flett addressed the Committee and responded to questions raised by the Committee.

Both Sergeant Flett and the applicant summed up their case.

Councillor Alexander moved to grant the licence renewal in respect of Case No. TD/19/005 as he was satisfied that on the balance of evidence the applicant was a fit and proper person. This was seconded by Councillor Divers.

Councillor Coy was of the view to refuse to grant the application for the renewal as she was satisfied on balance that the applicant was not a fit and proper person to hold a taxi driver licence having regard to the evidence presented. Therefore a ground for refusal existed and proposed that the Committee was obliged to refuse. The amendment was seconded by Councillor Macrae.
