# SUBJECT: INFORMATION REPORT: SUMMER ACTIVITIES FUNDING (TARGETED PROVISION)

#### 1. REASON FOR REPORT

- 1.1 The report provides an update to Committee on the Summer of Activities for Children and Young People (Targeted Provision) delivered during the summer holidays.
- 1.2 This report is submitted to the Council in terms of Section III (D) (1) of the Council's Scheme of Administration relating to all the functions of the Council as Education Authority.

## 2. BACKGROUND

- 2.1 At a special meeting of Council on 16 June 2021 (para 6 of the minute refers) Members approved a report outlining plans for the targeted provision of summer holiday activities utilising £256,000 of funding from the Scottish Government.
- 2.2 The priority across the investment was to improve the wellbeing of children and young people, providing opportunities for them to socialise and reconnect with peers and their local communities during the summer through the delivery of a range of activities, with food and family support integrated where needed within local communities.
- 2.3 Members agreed a programme of activities delivered in partnership with a number of local providers and partners, with a particular focus on supporting children and young people most likely to be experiencing continued disadvantage and who would therefore have been particularly adversely affected by the pandemic.
- 2.4 The programme was successfully delivered across Moray. All partners have completed their evaluations of the programme and an evaluation summary has been returned to the Scottish Government and is included as Appendix 1 to this report.

- 2.5 The evaluation report highlights a number of successes of the programme including:
  - The development and strengthening of new and existing partnerships
  - The benefits of meaningful engagement with children and young people to develop programmes and supports that they said would benefit them.
  - The depth and range of the offer, despite the short lead in time, ensuring we could meet a variety of different needs across our different localities.
  - The funding allocated to overcome barriers to accessing universal provision, giving children, young people and families from the target groups the same opportunities as others.
  - Direct funding to families so that they felt valued and trusted.
- 2.6 The enhanced summer programme was developed through the revised locality planning model, with locality networks engaging with children and young people, and local practitioners and partners working together to develop and deliver offers to meet identified needs. The process was overseen by the Wellbeing Partnership Group. The Wellbeing Partnership Group will take the learning from the summer programme and consider how partners can continue to work together to meet needs during future holiday periods.
