GUIDANCE NOTES

- Declaration of Group Decisions and Members Interests The Chair of the meeting shall seek declarations from any individual or political group at the beginning of a meeting whether any prior decision has been reached on how the individual or members of the group will vote on any item(s) of business on the Agenda, and if so on which item(s). A prior decision shall be one that the individual or the group deems to be mandatory on the individual or the group members such that the individual or the group members will be subject to sanctions should they not vote in accordance with the prior decision. Any such prior decisions will be recorded in the Minute of the meeting.
- ** Written Questions Any Member can put one written question about any relevant and competent business within the specified remits not already on the agenda, to the Chair provided it is received by the Proper Officer or Committee Services by 12 noon two working days prior to the day of the meeting. A copy of any written answer provided by the Chair will be tabled at the start of the relevant section of the meeting. The Member who has put the question may, after the answer has been given, ask one supplementary question directly related to the subject matter, but no discussion will be allowed.

No supplementary question can be put or answered more than 10 minutes after the Council has started on the relevant item of business, except with the consent of the Chair. If a Member does not have the opportunity to put a supplementary question because no time remains, then he or she can submit it in writing to the Proper Officer who will arrange for a written answer to be provided within 7 working days.

*** Question Time - At each ordinary meeting of the Committee ten minutes will be allowed for Members questions when any Member of the Committee can put a question to the Chair on any business within the remit of that Section of the Committee. The Member who has put the question may, after the answer has been given, ask one supplementary question directly related to the subject matter, but no discussion will be allowed.

No supplementary question can be put or answered more than ten minutes after the Committee has started on the relevant item of business, except with the consent of the Chair. If a Member does not have the opportunity to put a supplementary question because no time remains, then he/she can submit it in writing to the proper officer who will arrange for a written answer to be provided within seven working days.

1. Chair

Councillor Paul McBain, as Chair of the Licensing Committee, chaired the meeting.

8. Registration of Private Landlord - Case No RL-23-003 - [Para 14]

A report by the Depute Chief Executive (Economy, Environment and Finance) informed the Committee of an objection from Police Scotland to a landlord being registered as a private landlord under the requirements of the Antisocial Behaviour etc. (Scotland) Act 2004.

The legal advisor introduced the report and confirmed that the Committee had all received the additional meeting documents.

The Committee noted that the applicant was not in attendance. The Chief Constable was represented by Sergeant Neil Grant.

On the invitation of the Chair, Sergeant Grant addressed the Committee and responded to questions from members.

During consideration Councillor Bloomfield moved that the application be granted and this was seconded by Councillor Gatt.

Councillor Harris moved an amendment that the application be refused as she was of the opinion that the applicant was not a fit and proper person after hearing the Police objection. This was seconded by Councillor Fernandes.
