No supplementary question can be put or answered more than 10 minutes after the Council has started on the relevant item of business, except with the consent of the Chair. If a Member does not have the opportunity to put a supplementary question because no time remains, then he or she can submit it in writing to the Proper Officer who will arrange for a written answer to be provided within 7 working days.

#### 1. Chair

Councillor Sonya Warren, being co-Chair of the Licensing Board, chaired the meeting.

#### 2. Declaration of Member's Interests

## 3. Minute of meeting held 7 February 2024

The minute of the meeting held 7 February 2024 was submitted and approved.

#### 4. Linn House 24-00343-PREVMA

The Legal Advisor introduced the application as a major variation and advised that there were no objections or representations, and all paperwork was in order.

PC Dickson confirmed there was nothing more to added from Police Scotland.

The applicant's representative addressed the Board and responded to the questions asked.

#### 5. Rothes Golf Club 24-00468-PREVMA
