CTB Response:	An extensive survey of all the large and significant buildings in the greater vicinity of Forres conducted several years ago confirmed that the Town Hall is the only building in Forres which has the capacity and structure to provide a viable venue for the Forres & District Pipe Band and its associated tuition programme and the Junior Band. In addition to the musical aspects of the band, by providing free tuition to youngsters over the age of 8, we give them a skill for life and access to a wholesome environment based on mutual respect and interdependency. In particular we have 35 youngsters learning to play the pipes and drums in our tuition Scheme and a further 15 youngsters (and growing) in our junior band. This has taken a good few years to set up purely through the efforts of a team of volunteers and the Town has embraced the band a never before. Should the asset not be transferred to FACT then the band would have nowhere to practice nor would the the youngsters have a tuition venue. It would therefore be almost impossible to keep the band and the tuition scheme going in its present form. To loose the Town Hall would not only be catastrophic for the band but it would also undermine a valuable social and skill based programme for the 50 + youngsters within our Tuition Scheme.
